



## VOLUNTEER/VISITOR LIABILITY FORM 2020

 (“volunteer”) releases Street Kids Direct, UK, and SKD Guatemala, (“charity”) and each of its directors, officers, employees and agents.

The volunteer understands that the scope of their relationship with the charity is limited to a volunteer position and that no compensation is expected in return for services provided by the volunteer; that the charity will not provide any benefits traditionally associated with employment to the volunteer; and that the volunteer is responsible for his/her own insurance coverage in the event of personal injury as a result of the volunteer services to the charity.

1. **WAIVER AND RELEASE:** I, the volunteer, release and forever discharge and hold harmless the charity and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to the charity. I understand and acknowledge that this release discharges the charity from any liability or claim that I may have against the charity with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services that I provide to the charity or occurring while I am providing volunteer services.
2. **INSURANCE:** Further I understand that the charity does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of the charity beyond what may be offered freely by the charity in the event of such injury or medical expenses incurred by me.
3. **MEDICAL TREATMENT:** I hereby release forever discharge the charity from any claim whatsoever which arise or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the charity.
4. **ASSUMPTION OF RISK:** I understand that the services that I provide to the charity may include activities that may be hazardous to me including, but not limited to activity such as “construction work”, “street work” or hazardous activities involving inherently dangerous activities. As a volunteer I hereby expressly assume the risk of injury or harm from these

activities and release the charity from all liability for injury, illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.

5. **PHOTOGRAPHIC REALEASE:** I grant and convey to the charity all right, title and interests in any and all photographs, images, video or audio recordings or my likeness or voice made by the charity in connection with my providing volunteer services to the charity.
6. **OTHER:** As a volunteer, I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the country of the United Kingdom, Guatemala, Honduras or the country where I normally reside and that this release shall be governed by and interpreted in accordance with the laws of the United Kingdom, Guatemala, Honduras or the country where I normally reside. I agree that in any event that any clause or provision of this release is deemed invalid, the enforceability of the remaining provisions of this release shall not be affected.
